

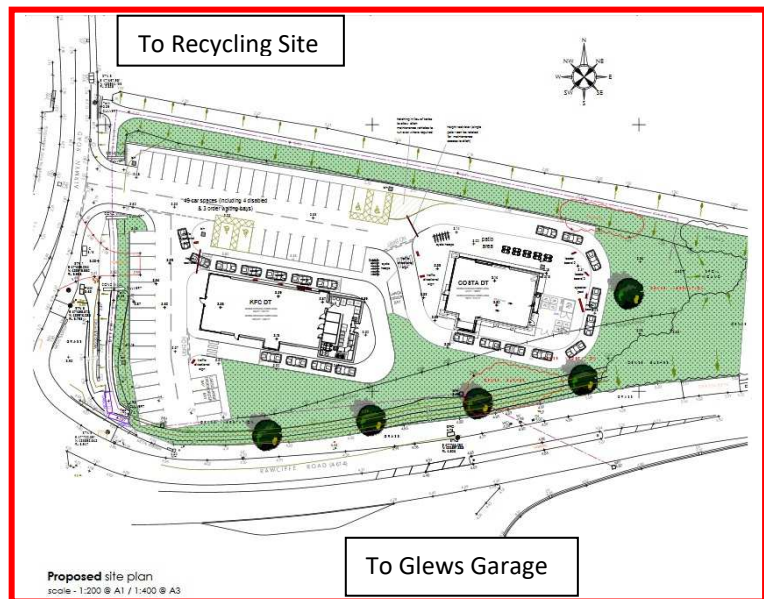

### **Airmyn Play Park Project - Phase 1**

Over the last year **Airmyn Parish Council** has been working hard to update and re-develop Airmyn Play Park to ensure it provides safe and positive play experiences for the children and families of the village. The park in its previous state was ageing and was last updated over 10 years ago. Phase 1 has been completed to resolve a number of issues and remove unsuitable items and replace them with new and exciting equipment.

We carried out consultation with children at Airmyn Primary School to ensure that the new equipment is what children want and will gain enjoyment from. We identified and sourced funding grants to cover the large majority of the work undertaken, with donations and council funds covering small amounts of the money required.

We would like to take this opportunity to thank **The National Lottery Community Funds Awards for All grant fund, Goole Fields Wind Farms Community Fund and Rusholme Wind Farm Community Benefit Fund** for their funding grants which have made phase 1 of the re-development possible. The Parish Council would also like to thank Phil from **Team Sport and Play Ltd**, who has installed the new equipment and completed the work to a very high standard. All work undertaken on the park is listed below:

1. Removal of the old tunnels, huts, concrete bases and hills.
2. Clearance of the surrounding dykes to aid drainage of the whole playing field & park.
3. Removal of the old Infant swing set and flooring. Replaced with a new metal frame and new flooring.
4. Installation of new equipment: Titan Rotator, Double See Saw & 2 metre Trampoline with flooring.
5. Removal of an old wooden bench (relocated onto the dog walk) and replaced with a new recycled plastic family bench. Re-installed the current recycled plastic picnic table into the ground at the correct height.
6. Repairs to a number of pieces of existing equipment.
7. Relocated the swing bridge into the trim trail to ensure the trail has no gaps.
8. Painting the surrounding fencing and replacement of two broken fence panels and posts.

The whole of the play park is now open for the community to enjoy. Please can we ask that users report any misuse of the facility to the Parish Council and ensure that all litter is put into the bin provided or taken away with you? Can we also take this opportunity to remind users not to allow their dogs to access the park or field facilities, as such action is prohibited. The dog walk provides a great facility for dog owners to walk their pets and we recommend that it is used to its maximum.

**Public participation:** 2 members of the public & 1 contractor present.

**Seats:** with the loss of the walk round the Cricket pitch more people are using the 'dog walk' path round the hall field, but there is nowhere to sit, can some seats be provided? Cllr Healey stated that a seat is currently being made for the Crossings and this new request can be investigated further.

**Opening the meeting:** Vice-Chair, Cllr Healey opened the meeting at 7pm and welcomed everyone.

**Present:** Cllrs Healey, Hayward, Jackson, Scott, Batten, Lynch; Clerk, R Charlesworth (minutes).

**Apologies:** Cllr Fox

**Minutes of the Parish Council meeting held on 13 Mar 2019:** Approved.

**Declarations of interest:** None

### Ongoing issues

**Grass contract:** G Fillingham in attendance to discuss contract. Current contracts extend to end March 2020. The original specification was for 15 cuts, this was previously increased to 20 to allow for longer growing season. Resolved that G Fillingham should work to contract specification. Cllr Healey expressed thanks to G Fillingham for his attendance and confirmed that he can continue working to the specification, spacing the 20 cuts out evenly through the season (Proposed: Cllr Scott; Seconded: Cllr Jackson). **Action:** Clerk to write confirmation letter to G Fillingham.

**Play area:** Cllr Jackson presented an update on the Play Area, work starting on new equipment next week for 2 weeks. Funding bid in for path & junior swing, £10,985. Fence repairs complete.

**Planning** 19/01038/VAR - Walkers Close – amendments to existing approved plans – no objections.

**New correspondence: Elections** for all Parish Councils due on 2<sup>nd</sup> May - 9 positions on APC. 7 applicants elected uncontested.

### Issues raised by councillors.

**Fence around play area:** Cllr Jackson reported a section of broken fence to the right of the Play area entrance which he has repaired. Cllr Healey expressed thanks for this repair.

### Clerk report:

**Grass contracts** – advice has been requested from ERYC on confidentiality aspects of contracts, responses will then be provided to resident enquiries.

**Xmas tree:** the tree by the Clock Tower needs removing. **Action:** Cllr Jackson to investigate.

**TdY:** £250 funding from ERYC granted, Cllr Scott has purchased flags. Cllr Fox has asked if some can be placed on Elite fencing to mark entrance to Airmyn.



**Riverbank issues:** both ERYC and EA have provided advice on the livestock and are in regular contact with the landowner. The EA conduct riverbank inspections through Airmyn at least every 6 months. **Action:** Clerk to respond to resident enquiry.

**Soil dumping:** the landowner has not commented on this issue. **Action:** Clerk to respond to resident enquiry.

**Horse escape:** the landowner has stated that the horse owner is responsible for securing the field and is due to install an electric fence.

**Upcoming meetings.**

**Village taskforce:** village taskforce walkabout on Tuesday 21<sup>st</sup> May at 09:45. The Clerk will attend along with any other available councillors. **Action:** any issues for review to be notified to Clerk by 20<sup>th</sup> May.

**Annual Parish Meeting:** agenda to follow last years format and invites to send. **Action:** Clerk to send invites to village groups.

**Ward Councillors report.**

Clr Healey reported an item on behalf of Clr Fox. The Police can attend a future meeting to advise on security, visits can be arranged for Clrs to visit Hessle to see Humberside Police systems and possible financial assistance is available from the Police and Crime Commission.

**Safety concerns.**

Clr Batten reported the Clock Tower clock showing incorrect time, Clr Hayward has already reported this and being dealt with.

**Financial matters.**

Bank reconciliation: Account statement provide for review.  
ERNLLCA membership due renewal, £382.88, resolved to renew (Proposed: Clr Batten; Seconded: Clr Scott).

**Staff matters:** Transferred to ACA meeting.

**Meeting close:** The Chair thanked everyone for their attendance and closed the meeting at 7.50pm.
