### **CHAIR'S INTRODUCTION:**

I hope all Airmyn parishioners had a very Merry Christmas and a Happy New Year.

You may well be wondering why you have received this publication from Airmyn Parish Council? You may recall that in the article included in the Airmyn News in October 2022, the parish council gave a commitment that it would communicate and engage more frequently with its residents. This we have tried to do via the Airmyn News and our Facebook page. However, the council was conscious that it could be seen as dominating the Airmyn News, which is an excellent and informative community publication. Therefore, after consulting with Mrs Queijo and the editorial team at the Airmyn News, the parish council agreed to produce and distribute to every household a parish council specific publication in the month of January (no Airmyn News was scheduled for publication in January).

I think it is fair to say that the last six months on the parish council have been quite eventful. There have been five councillor resignations during that time and a period where the council was not quorate. Fortunately, five residents applied and were subsequently co-opted onto the council. For information, your Airmyn Parish Councillors are included within this newsletter. There are even photographs to allow you to familiarise yourself with your representatives.

Despite only being in place for five months, the current crop of parish councillors, in my personal opinion, are possessed of a remarkable and diverse range of experience, skills and aptitudes which, collectively, make Airmyn Parish Council an effective and dynamic organisation which is starting to do much good for the residents of Airmyn in many different aspects of village life.

However, all the parish councillors have been co-opted onto the council. Parish Councils are permitted to exercise the power to co-opt a person onto the Council to fill a casual vacancy when the requirements to hold an election have not been met (i.e. the vacancy has been the subject of a public notice and less than 10 registered electors have requested an election by a deadline date specified by East Riding of Yorkshire Council Returning Officer). I firmly believe that the ideal objective is for every parish and town councillor to be elected by way of receiving the most votes at an election. This gives the council a mandate to say they have been elected by, and empowered to make decisions on behalf of the local residents. A separate article is included on the forthcoming election.

We have now completed our budget setting for 2023-24 and despite a very challenging economic climate we are pleased that we were able to balance our budget. This means that Airmyn taxpayers will not see an increase to the proportion of their Council Tax collected for Airmyn over the next year. An article on the budget is included within this newsletter.

The parish council is looking to re-establish community events within the parish. This year, the Kings Coronation will be celebrated, as well as Bonfire Night. Airmyn is blessed to have a fantastic village hall in the heart of its community. Consequently, the council is, in association with Airmyn Community Association, exploring the possibility of community events being held from the Memorial Hall. Further details will follow in due course.

We hope you find this newsletter interesting and informative.

- 1. Be a British Citizen or Citizen of the Commonwealth or European Union
- 2. Be 18 years or older on the day you are nominated for election.
- 3. For the whole 12 months prior to nomination for election you have been either an elector of the parish and either occupy or rent/own premises in the parish or reside within 3 miles of the boundary of the parish or have your principal or only place of work in the area.

You can obtain a nomination paper from the Parish Office or the Elections Office at East Riding of Yorkshire Council. You will need to find two people to nominate you.

### **Footpath Works**

Airmyn Parish Council are aware of the deterioration of the footpath surface in the far kissing-gate at the Clock Tower entrance to the riverbank. The issue was raised with ERYC at the beginning of December 2022 and will be followed up in January 2023, to ensure suitable action is taken.

### **Community Speed Watch Update:**



Airmyn continues to be a member of Community Speed Watch, an initiative introduced by the Humberside Police and Crime Commissioner. Community Speed Watch allows residents, particularly those in rural communities, to become police-trained volunteers monitoring vehicle speeds in their communities, with the aim of changing the behaviour of some road users who drive above the speed limit through small towns and villages.

Airmyn is fortunate to have 12 trained volunteers, who can regularly be seen in various locations in the village monitoring the speed of passing vehicles. The Parish Council wishes to place on record its thanks to the twelve volunteers for enforcing the speed limit in the village.

Statistics collated by the volunteers reinforce the perception that some motorists do speed through the village, with one motorist recorded travelling at 49 mph.

The Parish Council is aware that residents who live at 'White City' are understandably concerned about the speed of vehicles passing their homes. Our Parish Clerk has been in dialogue with Humberside Police, seeking permission to include 'White City' in the Community Speed Watch programme. However, the council was informed that Community Speed Watch can only operate in areas with a speed limit of 30 mph or 40 mph. Whilst this is disappointing, the Parish Council will continue to liaise with Humberside Police to explore options to ensure the speed limit on the road is monitored and enforced (where necessary).

### **Defibrillators:**

**Airmyn** is fortunate to have three defibrillators in the village; two at the Memorial Hall and one at the residential home on the High Street.

A defibrillator (or AED) is a device that gives high energy electric shock to the heart of someone who is in cardiac arrest and can help to save a life. After a cardiac arrest, every minute without CPR (cardiopulmonary resuscitation) and defibrillation reduces someone's chance of survival by 10 per cent.

No formal training is necessary for using them. In the event of an emergency **CALL 999**, if you do not already know where the defibrillator is located, the ambulance service will direct you. The defibrillator itself is a fully mobile unit, which is kept inside a heated cabinet to ensure that it is kept in full working order. Remove the defibrillator from the cabinet. When the defibrillator is opened, full instructions are given, both spoken and with diagrams.

Do not worry, it will not allow you to hurt the patient, but you may save a life!

...The devices are inspected regularly by local resident Sylvia Scott to ensure that, if the need arises, they are working perfectly. The parish council has, following advice from Mrs Scott, purchased new pads to ensure that they are fit for purpose. The parish council thanks Mrs Scott for her diligence in monitoring the defibrillators.

The parish council, in 2022, funded a defibrillator training session for local residents. If there is enough interest, the council would happily provide another training course for parishioners.



### What is the precept and how is it calculated?

The process of calculating how much of our Council tax is allocated to the local council (in our case Airmyn Parish Council) may not be obvious.

There are essentially two parts: the local council sets a budget (which is only lawful when approval is voted for by a majority of Councillors), and the rating authority – in our case East Riding of Yorkshire Council (ERYC) – assesses the 'tax base figure', which is the quantity of properties in the parish contributing the equivalent of Band D Council Tax contributions.

The parish council and the Parish Clerk (who is our Financial Officer) gather together estimates for items such as suggestions from local residents and councillors, legal requirements, recent experiences, proposed new projects, anticipated necessary maintenance, as well as estimated of both earmarked and general reserves. We then use the previous year's budget and spending and our best estimates of what else is anticipated, to propose a budget for the following year.

For 2023-24 this process was considered by the council at an extra-ordinary meeting in December 2022. The entire budget was scrutinised line item by line item, culminating in the parish council agreeing the budget, which is included below.

For 2023-24, our budget included an expenditure of £26,303. This is slightly over the 2022-23 budget of £26,250. However, to ensure that there was a zero percent increase on the council tax council submitted to ERYC, the Clerk submitted a precept requirement of £26,250 (the balance between the precept requirement and the proposed budget will be met from our parish council reserves).

Meanwhile ERYC calculate the number of houses in Airmyn Parish and adjust them firstly to get the equivalent number of Band D dwellings. There is a UK fixed ratio of Council Tax payable in ratio to those for the average, Band D dwelling – ranging from 67% of a Band D for the least valuable Band A up to 200% for the most valuable Band H. Then ERYC make adjustments, subtracting for those exempt or paying reduced Council Tax. Obviously this is a best estimate for the year to come.

For 2023-24, ERYC set the tax base for Airmyn Parish as 297.7 Band D equivalents. This tax base figure was released by ERYC just before our December extra-ordinary Parish Council meeting so it was not until then that we could know the rate per household.

The parish council agreed, for the second year running, to a zero percent increase on the council tax. Therefore, local residents will continue to pay £87.94 per annum for a Band D property in the parish.

However, we may all see our council tax bills increase due to East Riding of Yorkshire Council, Humberside Fire and Rescue Service and the Police and Crime Commissioner (who collectively with Airmyn Parish Council make up the council tax bill) potentially agreeing an increase in their respective precept.

### **PLAY AREA IMPROVEMENTS:**



Airmyn boasts a beautiful playing field and associated grounds that is open to all. It includes a picturesque dog walk and the children's' play area. The play area has been designed to be inspiring and inclusive for all, which does not segregate by age or ability, welcomes nature in and creates a social hub for the village. Airmyn Parish Council strives to maintain all our facilities to a high standard.

Airmyn park attracts many visitors, not only from Airmyn but surrounding villages and towns. Consequently, there has been some wear and tear to the play area, especially the areas to the sides of the slides. Therefore, the parish council has agreed to instruct a

contractor to install a bonded rubber mulch to the sides of the slides to cover the erosion as it provides a tested surface, can flow up and over mounds and gives a natural aesthetic. The type of material to be used can be seen from the photo above. Continued...

...The cost of the repair will be met from the parish council's reserves and not passed on to Airmyn parishioners.

Further discussions are being held with the contractor to improve and enhance the area surrounding the trampoline. The council will keep you informed of further developments to the playing fields and associated areas.

Trees have also been planted within the play area to, over time, provide shade to families who use the park.

Despite the parish council's efforts to maintain the playing fields and associated areas, there have been examples of vandalism to equipment within the facility, particularly litter bins, fences and the football goal posts. Due to the severity of the vandalism to the goalposts, they have been locked together as they have been risk assessed as being dangerous. It is extremely disappointing that such a well-used facility and valuable asset can be vandalised in such a mindless way.

### AIRMYN COMMUNITY ORCHARD AND PICNIC AREA:





Residents who are familiar with our playing field will know the area to the west of the dog walk boundary fence that was dedicated as a Jubilee celebration and is planted with 10 sturdy oak saplings (one of which originated from the late Queens Estate in Sandringham). In recent years this area has been largely unused and not maintained but now we are breathing new life into it by revealing 4 fruit trees that were planted many years ago but were largely hidden from view by nettles, thistles and Himalayan balsam and which have now been opened up and extended by a further 6 heritage mixed apple/pear trees along with 5 more blackcurrant bushes. We intend to maintain the grass area in future and install 3 picnic bench tables (along with a couple of other benches along the southern boundary fence) and an appropriate number of waste bins. It is also hoped that we can improve the surface as during winter months it is quite muddy.

The Parish Council are aware of the problem with flooding at Boothferry Bridge roundabout when there is heavy rainfall.


This was raised by councillors in November and has since been reported to the Highways Maintenance team and disscussed again in January.


